RESOLUTION 21-03-08-25

**RESOLUTION APPROVING THE REQUIRED MATCH FOR THE
MINNESOTA DEPARTMENT OF TRANSPORTATION,
TRANSPORTATION ALTERNATIVES PROGRAM GRANT**

- WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly elected legislative body for the Non-Removable Mille Lacs Band of Ojibwe (“Band”), a federally recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBS § 3(d), the Band Assembly has the authority to adopt resolutions; and
- WHEREAS, pursuant to 3 MLBS § 1(m), a “resolution” is defined as “a formal expression of the opinion, will, or intention” of the Band Assembly; and
- WHEREAS, pursuant to 3 MLBS § (f), the Band Assembly has the authority to ratify agreements, contracts, cooperative and reciprocity agreements, and memoranda of understanding; and
- WHEREAS, the Band’s Department of Community Development is eligible for state and federal funding; and
- WHEREAS, Band Assembly recognizes the importance of improving safety in the Band communities by ensuring opportunities to make pedestrian walkways safer for adults, children, and those with disabilities along Highway 169 and Bugg Hill Connection within District 1 of the reservation; and
- WHEREAS, the Band Assembly recognizes that the Band is required to commit cost-sharing monies or in-kind resources to receive federal funding for \$800,000.00, of which \$160,000.00 (20 percent) is the needed match; and
- WHEREAS, the Federal Highway Administration (FHWA) requires that states agree to operate and maintain facilities constructed with federal transportation funds for the useful life of the improvement and not change the use of the right of way or the property ownership acquired without prior approval from the FHWA; and
- WHEREAS, the Minnesota Department of Transportation (MnDOT) has determined that for projects implemented with transportation alternative funds, this requirement should be applied to the project proposer.

Sponsorship includes the willingness to secure and guarantee local share costs associated with this project and responsibility for seeing the project through to completion, with compliance with all applicable laws, rules, and regulations; the sponsoring agency hereby agrees to assume full responsibility for the operation and maintenance of property and facilities related to the aforementioned transportation alternatives project.
