## RESOLUTION 21-03-23-25

### A RESOLUTION AUTHORIZING A CONSTRUCTION EASEMENT FOR ROADS CONSTRUCTION ADJACENT TO THE MILLE LACS BAND DISTRICT I RESERVATION ROADS

- WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly elected legislative body for the Non-Removable Mille Lacs Band of Ojibwe (“Band”), a federally recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBS § 3(d), the Band Assembly has the authority to adopt resolutions; and
- WHEREAS, pursuant to 3 MLBS § 1(m), a “resolution” is defined as “a formal expression of the opinion, will, or intention” of the Band Assembly; and
- WHEREAS, pursuant to 3 MLBS § (f), the Band Assembly has the authority to ratify agreements, contracts, cooperative and reciprocity agreements, and memoranda of understanding; and
- WHEREAS, the temporary construction easement for the purposes of authorizing road construction is to be conveyed to the Band’s Public Works Department across the following reservation roads for the Wagidaaki/Ookwemin Loop Walkways and Paving Attage/Ojibwe/Anishinabe/Mosey Dr. Roads as follows:
- IRR Route #50 Aatage Drive, 1.2 miles in length
  - IRR Route #52 Mosey Drive, 0.2 miles in length
  - IRR Route #53 Ojibwe Drive, 0.6 miles in length
  - IRR Route #54 Anishinabe Drive, 0.2 miles in length
  - IRR Route #6 Wagidaaki Drive, 0.2 miles in length
  - IRR Route #94 Wagidaaki Drive, 1.0 miles in length
  - IRR Route #180 Ookwemin Loop, 0.3 miles in length; and
- WHEREAS, the Band Assembly has determined that the overall benefits of the temporary construction easement off sets any of the compensation benefits for the temporary construction easements; and
- WHEREAS, the Band’s Public Works Department will retain control and jurisdiction of said easement and temporary construction easement.
