RESOLUTION 21-04-53-25

A RESOLUTION ADOPTING THE FY 2025-2028 MILLE LACS BAND TRANSPORTATION IMPROVEMENT PLAN, FY 2025 TRIBAL TRANSPORTATION PROGRAM AGREEMENT RETAINED SERVICES ADDENDUM, AND FY 2025 REFERENCED FUNDING AGREEMENT WITH THE UNITED STATES DEPARTMENT OF INTERIOR - BUREAU OF INDIAN AFFAIRS

WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly elected legislative body of the Non-Removable Mille Lacs Band of Ojibwe (“Band”), a federally recognized Indian Tribe; and

WHEREAS, pursuant to 3 MLBS §§ 3(d) and 3(f), the Band Assembly is empowered to adopt resolutions to promote the general welfare of the people of the Band and to ratify agreements, contracts, cooperative and reciprocity agreements, and memoranda of understanding; and

WHEREAS, pursuant to 3 MLBS § 1(m), a “resolution” is defined as “a formal expression of the opinion, will, or intention” of the Band Assembly; and

WHEREAS, the Band Assembly has established as a priority the improvement of spiritual, physical, mental, social, and economic well-being of the people of the Band; and

WHEREAS, transportation plays an integral role in serving local infrastructure and community needs; and

WHEREAS, the Band desires to provide adequate transportation facilities to meet the needs of the residents of the Band; and

WHEREAS, the Band has worked to develop the FY 2025 Mille Lacs Transportation Improvement Plan (“TIP”), Retained Service Agreement (“RSA”), and Referenced Funding Agreement (“RFA”) which the Band is using to request the Bureau of Indian Affairs (“BIA”) to incorporate into the Control Schedule Transportation Improvement Plan (“CSTIP”), a required step to help the Band receive its Tribal Shares funding; and

WHEREAS, the RSA shows the professional services the BIA will provide, such as engineering or environmental services for TIP projects; and

WHEREAS, the RFA shows the summary funding, including the amount and sources; and


