**RESOLUTION 21-03-39-25**

**A RESOLUTION TO CANCEL A RESIDENTIAL LEASE AUTHORIZED BY BAND RESOLUTION 16-02-20-15**

WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly elected legislative body for the Non-Removable Mille Lacs Band of Ojibwe (“Band”), a federally recognized Indian Tribe; and

WHEREAS, pursuant to 3 MLBS § 3(d), the Band Assembly has the authority to adopt resolutions; and

WHEREAS, pursuant to 3 MLBS § 1(m), a “resolution” is defined as “a formal expression of the opinion, will, or intention” of the Band Assembly; and

WHEREAS, tribal land leases are required on all tribal lands of the Mille Lacs Band Ojibwe for agricultural purposes, to establish a home-site or a seasonal recreational residence, and for any commercial activity, or to acquire financing for a home; and

WHEREAS, Band Resolution 16-02-30-15 authorized a residential land lease for the purpose of obtaining a lease site; and

WHEREAS, the land lease was to be for a period of 25 years and renewable for an additional 25 years, subject to the lease provisions, effective upon date of approval, for the property described herein; and

WHEREAS, said land is described as follows:  
That part of Tract 410TF000277, located in the North Half of the Northwest Quarter of the Southwest Quarter of the Northwest Quarter of the Southeast Quarter (N1/2NW1/4SW1/4NW1/4SE1/4) and the South Half of the Southwest Quarter of the Northwest Quarter of the Northwest Quarter of the Southeast Quarter (S1/2SW1/4NW1/4NW1/4SE1/4), in Section 30, Township 42N, Range 27W, Mille Lacs County, Minnesota, Fourth Principal Meridian.  
This lease site is 2.5 acres more or less; and

WHEREAS, the lessee voluntarily relinquishes the land lease authorized by Band Resolution 16-02-20-15 and requests this lease site revert back to the Band.

NOW, THEREFORE, BE IT RESOLVED, the Band Assembly approves the cancellation of the land lease authorized by Band Resolution 16-02-20-15.
