**RESOLUTION 21-03-25-25**

**RESOLUTION PETITIONING THE MINNESOTA BOXING HALL OF FAME TO GRANT MEMBERSHIP TO HARRY DAVIS, THE DISTRICT III REPRESENTATIVE OF THE NON-REMOVABLE MILLE LACS BAND OF OJIBWE ASSEMBLY, IN RECOGNITION OF HIS EXCEPTIONAL CONTRIBUTIONS TO AMATEUR AND PROFESSIONAL BOXING IN MINNESOTA**

WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly elected legislative body for the Non-Removable Mille Lacs Band of Ojibwe (“Band”), a federally recognized Indian Tribe; and

WHEREAS, pursuant to 3 MLBS § 3(d), the Band Assembly has the authority to adopt resolutions; and

WHEREAS, pursuant to 3 MLBS § 1(m), a “resolution” is defined as “a formal expression of the opinion, will, or intention” of the Band Assembly; and

WHEREAS, pursuant to 3 MLBS § (f), the Band Assembly has the authority to ratify agreements, contracts, cooperative and reciprocity agreements, and memoranda of understanding; and

WHEREAS, District III Representative Harry Davis has made significant contributions to amateur and professional boxing in Minnesota over the past three decades; and

WHEREAS, Harry Davis has dedicated his life to the sport of boxing, mentoring countless young athletes and promoting the values of discipline, perseverance, and sportsmanship; and

WHEREAS, Harry Davis was instrumental in the creation of the Mille Lacs Band of Ojibwe – Department of Athletic Regulation, the second tribal athletic commission in the nation and the first in the state of Minnesota, furthering the development and regulation of boxing within tribal communities; and

WHEREAS, the Mille Lacs Band of Ojibwe recognizes the importance of honoring individuals who have made outstanding contributions to the sport of boxing and the community at large;

NOW, THEREFORE, BE IT RESOLVED, that the Band Assembly of the Non-Removable Mille Lacs Band of Ojibwe hereby petitions the Minnesota Boxing Hall of Fame to grant
