RESOLUTION 21-04-77-25

**A RESOLUTION APPROVING REVISIONS TO THE RENOVATION
LOAN PROGRAM POLICY OF THE MILLE LACS BAND OF OJIBWE
HOUSING DEPARTMENT**

- WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly elected legislative body for the Non-Removable Mille Lacs Band of Ojibwe (“Band”), a federally recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBS § 3(d), the Band Assembly has the authority to adopt resolutions; and
- WHEREAS, pursuant to 3 MLBS § 1(m), a “resolution” is defined as “a formal expression of the opinion, will, or intention” of the Band Assembly; and
- WHEREAS, pursuant to 12 MLBS § 1(p) the Band’s Commissioner of Community Development and Housing Board have authority to develop and approve housing policies that meet the Band’s housing vision and mission, subject to ratification by the Band Assembly; and
- WHEREAS, on November 6, 2025, the Band Housing Advisory Board approved the Mille Lacs Band of Ojibwe Housing Department Renovation Loan Program Policy, a copy of which is attached hereto; and
- WHEREAS, the Band Assembly has reviewed the revised Renovation Loan Program Policy and found it satisfactory and in the best interests of the Band.

NOW, THEREFORE, BE IT RESOLVED, the Mille Lacs Band Assembly does hereby authorize, approve, and ratify the attached version of the Mille Lacs Band of Ojibwe Housing Department Renovation Loan Program Policy.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a special session of the Band Assembly, in Legislative Council assembled, a quorum of legislators being present, held on the 17th day of December, 2025, at Nayahshing, Minnesota, by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
