RESOLUTION 22-01-07-26

A RESOLUTION SUPPORTING THE BAND'S PARTICIPATION IN THE MINNESOTA ANTI-HEROIN TASK FORCE PROGRAM JOINT POWERS AGREEMENT

- WHEREAS, the Mille Lacs Band Assembly (“Band Assembly”) is the duly elected legislative body for the Non-Removable Mille Lacs Band of Ojibwe (“Band”), a federally recognized Indian Tribe; and
- WHEREAS, pursuant to 3 MLBS § 3(d), the Band Assembly has the authority to adopt resolutions; and
- WHEREAS, pursuant to 3 MLBS § 1(m), a “resolution” is defined as “a formal expression of the opinion, will, or intention” of the Band Assembly; and
- WHEREAS, pursuant to 3 MLBS § (f), the Band Assembly has the authority to ratify agreements, contracts, cooperative and reciprocity agreements, and memoranda of understanding; and
- WHEREAS, the Band Assembly and Chief Executive have established as a priority the improvement of the spiritual, physical, mental, social, and economic well-being of the people of the Band; and
- WHEREAS, the Mille Lacs Band Tribal Police Department and the State of Minnesota, through the Commissioner of Public Safety on behalf of the Bureau of Criminal Apprehension, wish to enter into the Minnesota Anti-Heroin Task Force Program Joint Powers Agreement; and
- WHEREAS, the Joint Powers Agreement provides for overtime reimbursement for investigations related to the unlawful use of heroin and prescription opioids; and
- WHEREAS, the Band Assembly recognizes the importance of the Mille Lacs Band Tribal Police and Minnesota Bureau of Criminal Apprehension collaboration to combat illicit activities on the reservation and in Minnesota Indian Country; and
- WHEREAS, the Band Assembly has reviewed the Joint Powers Agreement and found it satisfactory and in the best interests of the Band.

NOW, THEREFORE, BE IT RESOLVED, that the Band Assembly hereby ratifies the Minnesota Anti-Heroin Task Force Program Joint Powers Agreement.
