RESOLUTION NO. 01 - 83

A CONTINUANCE RESOLUTION FOR THE PROGRAMMATIC, CORPORATE AND GOVERNMENTAL ACCOUNT STRUCTURES FOR THE MILLE LACS BAND OF CHIPPEWA INDIANS FOR FISCAL YEAR 1983 IN LIEU OF A FORMAL APPROPRIATIONS STATUTE.

WHEREAS, Ordinance 02 - 82, Section 8 mandates the appropriation of all Band revenue prior to the commencement of a new fiscal year, and;

WHEREAS, the Band Assembly adopted Resolution 35 - 82 as a continuance resolution to expire at midnight October 7, 1982 for the purpose of continuing essential services to enrolled members of the Mille Lacs Band, and;

WHEREAS, the Band Assembly of the Mille Lacs Band of Chippewa Indians continues to review all necessary financial information in order to ensure the financial integrity of the Band.

NOW THEREFORE BE IT RESOLVED, that the Band Assembly of the Mille Lacs Band of Chippewa Indians hereby authorizes the continuance of the following programs for a period of thirty days {30} to expire at midnight, November 6, 1982, said expenditures shall not exceed the amounts listed:

Should any program fail to have sufficient cash fund balance to continue operations, immediate program shut-down shall occur. Loans for programmatic operations shall not be authorized.


BE IT FURTHER RESOLVED, that: 1) Payment for furloughed employees who remained on duty during the interim period mandated by Resolution 35 - 82 is hereby authorized; 2) Payment for emergency travel which occurred during the interim period mandated by Resolution 35 - 82 is hereby authorized; 3) Consistent with the unanimous determination of the Reservation Business Committee in August, 1981 and the subsequent agreement to delay implementation until fiscal year 1983, the teacher position at the Head Start/Home Start Program is hereby de-funded effective the date of this Resolution; 4) Authorization request of the Ass't. Commissioner of Education to transfer employees of the Chapter 1 Program to the payroll account of Nay-Ah-Shing School is hereby disallowed and denied. Said effected employees are to be furloughed until such time as funds arrive for said program. Should any effected employee be part-time, a furlough is in order for only that portion of total time and; 5) It is hereby authorized and decreed that the Office of Management and Budget personnel shall work only four days per week with Wednesday as day-off with time not to exceed thirty-two (32) hours per week provided cash funds exist for payment of wages from each programic account. The Corporate structure of the Band is hereby authorized to continue operations during this period. The governmental accounts shall remain closed until funds are appropriated by band statute.

WE DO HEREBY CERTIFY, that the foregoing Resolution No. 01 - 83 was duly adopted at a session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present, held on October 8, 1982, at 12:32 a.m., at Vineland, Minnesota by a vote of 3 FOR, 0 AGAINST and 0 SILENT.
