WE DO HEREBY CERTIFY, that the foregoing Resolution was duly adopted at a legal session of the Band Assembly (Reservation Business Committee) in legislative council assembled, a quorum of legislators being present, held on Tuesday, April 3, 1984 at Vineland, Minnesota by a vote of 3 FOR, 0 AGAINST and 0 SILENT.
