RESOLUTION NO. 45-84

A RESOLUTION FOR TRANSFER OF LAND FROM THE MINNESOTA CHIPPEWA TRIBE TO NON-REMOVABLE MILLE LACS BAND OF CHIPPEWA INDIANS.

WHEREAS, the Mille Lacs Band of Chippewa has primary interest in land within their jurisdiction; and,

WHEREAS, certain parcels of land within the jurisdiction of the Mille Lacs Band were deeded to the Minnesota Chippewa Tribe through actions of the Minnesota Chippewa Tribe Home Loan Corporation; and,

WHEREAS, Charles Durant did obtain a home loan through said Corporation and was granted a land lease for the purpose of homesite; and,

WHEREAS, the Minnesota Chippewa Tribe Home Loan Corporation has obtained possession on the homesite land of Charles Durant; and,

WHEREAS, the Minnesota Chippewa Tribe Home Loan Corporation through said land lease agreement authorized by Resolution 02-81 as amended, claim ownership of said lease; and,

WHEREAS, the Minnesota Chippewa Tribe Home Corporation has no value of land and contents within the lease; and,

WHEREAS, the Bureau of Indian Affairs did not approve or Record said lease with the Land Office in Aberdeen, South Dakota as required by Federal law.

NOW THEREFORE BE IT RESOLVED, that the Minnesota Chippewa Tribe Home Loan Corporation hereby relinquishes all claims to said property.

BE IT FURTHER RESOLVED, that the Minnesota Chippewa Tribe Home Loan Corporation return said lease to Mille Lacs Band as quickly as possible.

BE IT FURTHER AND FINALLY RESOLVED, that the Minnesota Chippewa Tribe expediate their actions at their next Housing meeting at Grand Portage, Minnesota on May 7 & 8, 1984. Resolution No. 45 was duly concurred with and adopted at a formal session of the Band Assembly in Legislative Council assembled, a quorum of Legislators being present, held May 2, 1984 at Vineland, Minnesota by a vote of 3 for, 0 against, 0 silent.
