RESOLUTION 15-84

A RESOLUTION REGARDING THE CREATION OF A MINNESOTA
CHIPPEWA TRIBAL COURT OF APPEALS AND A TRIBAL GAMING/
BINGO STATUTE OR COMMISSION.

WHEREAS, appropriate sub-committees of the Minnesota Chippewa Tribe Executive Committee have considered and recommended a proposal to create a tribal Court of Appeals and to enact an ordinance which establishes a tribal gaming commission, and;

WHEREAS, the adoption of a proposal to create a tribal court of appeals conflicts with established cultural and legal systems enacted under Band Statute 1024-MLC-3 on March 21, 1983 at Mille Lacs, and;

WHEREAS, the enactment of a tribal gaming statute conflicts with various provisions of Band Statute 1000-MLC-4, Nay-Ah-Shing Gaming Commission enacted November 10, 1981, and;


WHEREAS, the adoption of these proposals by the Minnesota Chippewa Tribe Executive Committee will be inconsistent with the advancement of Indian Self-Determination principles and precepts and will constitute further erosion of the sovereignty of each Band which comprises the Minnesota Chippewa Tribe, and;

WHEREAS, the proposals are deemed to be further inconsistent with the rights of Self-Determination of the Mille Lacs Band which have been exercised through the enactment of said aforementioned statutes which established the Judicial system and Nay-Ah-Shing Gaming Commission.

NOW THEREFORE BE IT RESOLVED, that the Chief Executive {Chairman} and Speaker of the Assembly {Secretary-Treasurer} are hereby authorized to strenuously oppose adoption of these proposals and to cast negative votes during the requested roll-call votes on each proposal.


