RESOLUTION 52-84

A RESOLUTION TO CONFER CANDIDACY FOR ELECTED OFFICERS OF THE COURT OF CENTRAL JURISDICTION, THE PUBLIC WORKS COMMISSION AND THE CONSOLIDATED NAY-AH-SHING SCHOOL BOARD, ALL OF THE MILLE LACS BAND OF CHIPPEWA INDIANS.
