RESOLUTION NO. 03-40-85

A RESOLUTION GRANTING A LAND LEASE TO [REDACTED]

WHEREAS: [REDACTED] wishes the lease of a lot on the Mille Lacs Reservation for the purpose of a homesite, and;

WHEREAS: tribal land leases are needed for the purpose of a homesite on tribal land for the Mille Lacs Reservation, and;

WHEREAS: Said land is described as that part of the west $\frac{1}{2}$ of S.W. $\frac{1}{4}$ of Section 22 -T.50 N. -R. 23 W. Aitkin County described as follows: Commencing at the S.W. corner of said S.W. $\frac{1}{4}$ of Sec! 22; thence on an assumed bearing of N. 00° -37' -33' E. (along the west line of S.W. $\frac{1}{4}$ of Sec. 22) distance 80.39 ft.; thence bearing N. 32° -18' -30' E. (along the centerline of County Road NO. 14) distance 1287.19 ft, to the Actual Point of Beginning of the tract to described; thence continuing on N. 32° -18' -30' E. distance 7.00 ft.; thence bearing N. 19° -57' -04' E. (along the centerline of County Road No.14) distance 201.87 ft.; thence bearing S. 70° -02' -56' E. distance 241.71 ft.; thence bearing S. 19° -57' -04' W. distance 208.71ft,; thence bearing N. 70° -02' -56' W. distance 243.21 ft. to the Actual Point of Beginning.

WHEREAS: the lease will have to be for a period of 25 years plus 25 years effective August 6th, 1985 for the purpose of financing this home.

NOW THEREFORE BE IT RESOLVED, that the Mille Lacs Band Assembly approves a lease to be issued to [REDACTED] for the period of 25 years plus 25 years renewal effective August 6th, 1985 at the rate of \$1.00 per term.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a formal session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present,,held on August 6th, 1985 at Vineland, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
