RESOLUTION NO. 02-19-85

RESOLUTION GRANTING LAND LEASE TO BRATON [REDACTED]

- WHEREAS: [REDACTED] wishes the lease of a lot on the Mille Lacs Reservation for the purpose of a homesite; and,
- WHEREAS: Tribal land leases are needed for the purpose of a home-site on tribal land from the Mille Lacs Reservation; and,
- WHEREAS: said land is described as follows: that part of gov. lot 1, section 18-T. 41 N. -R 17,W. Pine County MN. described as follows: Commencing at the N.W. corner of section 18: Thence on an assumed bearing of S.0-14' E. along the west line of the N.W. $\frac{1}{4}$ of section 18, distance 1471.30 ft.; Thence bearing N. 82 -15'-31" E. distance 305.0 ft.; Thence bearing S.37 -04' -29" E. distance 85.50 ft.; Thence bearing N. 72 -23'-31' E: distance 244.0 ft.; Thence bearing S. 86 -08'E. distance 208.71,ft.; Thence bearing S.0 -14' E. distance of that tract to be described: Thence bearing N.0 -14' W. distance 208.71 ft; Thence bearing N. 89 -46' E. distance 208.71 ft; Thence bearing S. 0 -14' E. distance 208.71 ft; Thence bearing S. 89 -46! W. distance 208.71 ft; to the Actual Point of Beginning.
- WHEREAS: the lease will have to be for a period of 25 years plus 25 years,effecetive January 1st, 1985 for the purpose of financing this home.


