RESOLUTION 03-17-86

A CONTINUANCE RESOLUTION FOR THE PROGRAMMATIC, CORPORATE AND GOVERNMENTAL ACCOUNT STRUCTURE FOR THE MILLE LACS BAND OF CHIPPEWA INDIANS UNTIL NOVEMBER 14, 1985, WHICH IS IN LIEU OF A FORMAL APPROPRIATIONS STATUTE.

WHEREAS, Ordinance 02-82, Section 8 mandates the appropriation of all Band Revenue prior to the commencement of a new fiscal year; and,

WHEREAS, the Band Assembly has not passed formal appropriations to continue the essential services to the enrolled members of the Mille Lacs Band; and,

WHEREAS, the Band Assembly of the Mille Lacs Band of Chippewa Indians continues to review all necessary financial information in order to ensure the financial integrity of the Band.

NOW THEREFORE BE IT RESOLVED, that the Band Assembly for the Mille Lacs Band of Chippewa Indians hereby authorizes the continuance of the following programs for a period of fourteen days to expire midnight November 14, 1985, said expenditures shall not exceed the amounts listed:


