RESOLUTION 03-23-86

A RESOLUTION PERTAINING TO PLACING DOCKETS 18-B IN A APPROVED ACTIVITY FOR THE MILLE LACS BAND OF CHIPPEWA INDIANS.

- WHEREAS, on January 27, 1967, a Joint Resolution was enacted by the Mille Lacs, Leech Lake and White Earth Reservation Business Committees agreeing to the disbursement of Docket 18-B (P.L. 90-84) funds, and on December 13, 1968, a per capita disbursement was made to the Mississippi and Pillager Bands of the Minnesota Chippewa Tribe, and;
- WHEREAS, as of February 22, 1980, all attorney fees representing Docket 18-B (P.L. 90-84) were paid in full, and;
- WHEREAS, any amount remaining in these funds after payment of the item for which it is set aside, shall be apportioned to the Mille Lacs, Leech Lake and White Earth Reservations in the same proportions and for the same purposes as established for funds to be set aside under paragraph 2 hereof (as stated on Page 3 of the Joint Resolution of January 27, 1967, and;
- WHEREAS, the Mille Lacs Reservation Business Committee (Band Assembly) needs have changed since January 27, 1967, to meet the present needs in the area of Tribal Loan Programs.

NOW THEREFORE BE IT RESOLVED, that the Mille Lacs Reservation Business Committee (Band Assembly) is requesting by the resolution that the Bureau of Indian Affairs make the necessary transaction involving trust appropriation 9718, Activity 2605, Appropriation 9223-9723, Activity 2605, for these funds based on the formula used in the December 13, 1968 plan for the use and distribution of these funds and to plan said funds into the appropriation activities of the Mille Lacs Reservation Business Committee as follows:

Activity 2619: Tribal Loan Program - 100%

BE IT FURTHER AND FINALLY RESOLVED, that upon fund transfer of these amounts by the Bureau of Indian Affairs for the Mille Lacs Reservation Business Committee requests for a drawdown of these funds.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a session of the Band Assembly, in Legislative assembled, a quorum of legislators being present, held on November 21, 1985 at Vineland, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
