RESOLUTION 05-64-86

A RESOLUTION GRANTING SERVICE LINE ACROSS LANDS UNDER THE JURISDICTION OF THE NON-REMOVABLE MILLE LACS BAND OF CHIPPEWA INDIANS TO THE MILLE LACS COOPERATIVE POWER ASSOCIATION FOR THE PURPOSE OF ELECTRICAL SERVICES.

- WHEREAS, Mille Lacs Co-op maintains and Electrical service line on Garbow's Road (as defined by Vineland Hills Plot), and;
- WHEREAS, the Bureau of Indian Affairs has a road easement for Garbow's Road, and;
- WHEREAS, Garbow's Road has been rebuilt, and;
- WHEREAS, Mille Lacs Co-op electrical service lines need to be moved, and;
- WHEREAS, The Bureau of Indians Affairs will redefine the electrical service line within their easement, and;
- WHEREAS, Band Statute 1094-MLC-47 designates Rules and Regulations governing the issuance of service lines across lands under the jurisdiction of the Band, and;
- WHEREAS, pursuant to his statutory authority, the Commissioner of Natural Resources has reviewed the request of the Mille Lacs County Co-op and does hereby recommend that the Chief Executive approve said service line request.

NOW THEREFORE BE IT RESOLVED, that the Bureau of Indian Affairs is authorized to redefine electrical service along Garbow's roads and issue The Mille Lacs Cooperative Power Association a service line agreement for this electrical service. The Bureau of Indian Affairs is requested to officially record said service line agreement as a valid service line agreement across lands herein described. Said service line agreement subject to termination for cause pursuant to service line agreement of the Band and is granted for a period of one (1) year automatically renewable on the annual effective date of each successive calendar year unless terminated within thirty (30) days prior notice to the holder.

Said service line is also subject to provisions of the environmental protection laws of the United States of America and the Non-Removable Mille Lacs Band of Chippewa Indians. Upon the payment of said service line agreement said resolution shall be forwarded for official reading.

IN WITNESS WHEREOF, I, Roy Wedell, Commissioner of Natural Resources do hereunto recommend the signature of the Chief Executive to be affixed to this resolution and forwarded to the Band Assembly for concurrence.
