RESOLUTION NO. 03-12-86

A RESOLUTION TO RATIFY THE INDIAN HEALTH SERVICE - NE-IA-SHING CLINIC CONTRACT FOR FISCAL YEAR 1986.

WHEREAS, pursuant to Band Statute 1002-MLC-2, Section 2, the Band Assembly reserved the authority to ratify contracts and agreements, and;

WHEREAS, The Commissioner of Human Services did negotiate a contract with the Indian Health Service to continue to provide health care to members of the Mille Lacs Band for fiscal year 1986, and;

WHEREAS, The Solicitor General has reviewed this contract and has delineated a number of negotiating points on behalf of the Mille Lacs Band with said points remaining unresolved as of October 23, 1985.

NOW THEREFORE BE IT RESOLVED, that the Band Assembly does hereby ratify the provisions of the Indian Health Service contract for fiscal year 1986 as written and prepared by the Indian Health Service.

BE IT FURTHER RESOLVED, THAT the Commissioner of Human Services and the Solicitor General are authorized and directed to enter into negotiations, as requested by the Indian Health Service - Bemidji Area Director Allery's letter dated October 1, 1985 to Chief Executive Gahbow. With said negotiations to resolve disputed contractual provisions found in the letter of the Solicitor General dated September 30, 1985 to the Commissioner of Human Services.

BE IT FINALLY RESOLVED, THAT the Commissioner of Human Services and the Solicitor General to report final results of said negotiations with the Indian Health Service to the Band Assembly no later than April 24, 1986. With said date to coincide with the recommended time necessary to conclude and resolve contractual matters contained in Director Allery's letter. A copy of this Resolution to be forwarded to the Indian Health Service forthwith.

WE DO HEREBY CERTIFY, THAT the foregoing Resolution No. 03-12-86 was duly adopted at a legal session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present, held on Thursday, October 24, 1985 at
