RESOLUTION NO. 04-46-86

A RESOLUTION TO RATIFY THE TECHNICAL ASSISTANCE CONTRACT BETWEEN THE COURT OF CENTRAL JURISDICTION AND ZIONTZ, PIRTLE, MORISSET, ERNSTOFF & CHESTNUT

- WHEREAS, The Court of Central Jurisdiction has appropriated funds and grant funds from the Minnesota State Bar Foundation for the provision of training and technical assistance to the Justices of the Court of Central Jurisdiction; and,
- WHEREAS, The Court of Central Jurisdiction desires to have Mr. Alvin J. Ziontz of the Law Firm of Ziontz, Pirtle, Morisset, Ernstoff & Chestnut provide said technical assistance services to the Court; and,
- WHEREAS, Pursuant to the Provisions of 25 USC 81 any contract with Indian Tribes or Indians, shall be executed in accordance with Federal Law and bear the approval of the Secretary of Interior or his Designee; and,
- WHEREAS, Pursuant to the Provisions of Band Statute 1002-MLC-2, Section 2, the Band Assembly of the Non-Removable Mille Lacs Band of Chippewa Indians reserve the Legislative Power to ratify Contracts; and,
- WHEREAS, The Provisions of Band Law and Federal Law need to be complied with prior to the delivery of technical assistance services to the Court of Central Jurisdiction.

NOW, THEREFORE, BE IT RESOLVED, That the Band Assembly in and for the Non-Removable Mille Lacs Band of Chippewa Indians does hereby ratify the Technical Assistance Contract between the Court of Central Jurisdiction and the Law Firm of Ziontz, Pirtle, Morisset, Ernstoff & Chestnut in the amount of \$8,500.00.

BE IT FURTHER AND FINALLY RESOLVED, That the Band Assembly does hereby request formal approval of said Contract by the Secretary of Interior or his Designee, as expeditiously as possible in compliance with the Provisions of 25 USC 81.

WE DO HEREBY CERTIFY, that the foregoing Resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of Legislators being present, held on February 18, 1986, at Vineland, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.

IN WITNESS WHEREOF, We, the Band Assembly hereunto cause to have set the signature of the Speaker of the Assembly to be affixed to this Resolution upon the recommendation of the Court of Central Jurisdiction.
