RESOLUTION 02-01-30-87

A RESOLUTION TO APPOINT THE GENERAL AND PRECINCT ELECTION BOARDS FOR THE NON-REMOVABLE MILLE LACS BAND OF CHIPPEWA INDIANS.

WHEREAS, the Minnesota Chippewa Tribe has announced a general special election for the offices of Secretary/Treasurer, District I Representative and District II Representative, of the six Bands which comprise the Minnesota Chippewa Tribe, and;

WHEREAS, the Chief Executive did issue a Writ of Special Election on the 20th day of March, 1987 for the positions of Secretary/Treasurer, District I Representative and District II Representative, and;

WHEREAS, the popularly elected leadership of the Non-Removable Mille Lacs Band of Chippewa Indians did convene this day to review all qualifications of those members of the Band who seek constitutional elective office as authorized by the Constitution of the Minnesota Chippewa Tribe and the Minnesota Chippewa Tribal Election Ordinance No. 4, III (A).
