RESOLUTION 02-02-39-87

A SPECIAL REVENUE RESOLUTION GRANTING DISBURSEMENT FROM THE GENERAL SALES TAXATION ACCOUNT TO THE ADMINISTRATIVE OPERATING ACCOUNT OF THE MILLE LACS BAND OF CHIPPEWA INDIANS

WHEREAS, the Commissioner of Finance respectively requests authorization to disburse three thousand six hundred eighty-eight dollars and forty-one cents (\$3688.41) from the General Sales Taxation Account to the administrative Operating Account to cover Mille Lacs Electric in the Amount of one thousand five hundred seventy two dollars and fifty-five cents (\$1572.55), Five Hundred Dollars and no cents (\$500.00) for a loan to the Mille Lacs Reservation Public Works, Fifty Dollars and no cents (\$50.00) to the treasurers Bond, Sixty Five Dollars and Eighty-Six Cents (\$65.86) for Office Supplies, One Thousand Five Hundred Dollars and no Cents for Legal fees, pursuant to the provisions of the Band Statute 1085-MLC-37, Section 66.

NOW THEREFORE BE IT RESOLVED, that Harry D. Simons, Commissioner of Finance is hereby authorized and directed to disburse Three Thousand Six Hundred Eighty-Eight Dollars and forty-one cents (\$3688.41) from the General Sales Taxation Account to the Administrative Operating Account.
