RESOLUTION 02-02-38-87

A SPECIAL REVENUE RESOLUTION GRANTING DISBURSEMENT FROM THE GENERAL SALES TAXATION ACCOUNT TO THE ADMINISTRATIVE OPERATING ACCOUNT OF THE MILLE LACS BAND OF CHIPPEWA INDIANS.

WHEREAS, the Commissioner of Finance respectfully requests authorization to disburse fourteen thousand seven hundred twenty-four dollars and forty-five cents (\$14,724.45) from the General Sales Taxation Account to the Administrative Operating Account to cover Indirect Cost in the amount of Nine thousand two hundred ninety-six dollars and fifteen cents (\$9,296.15), Three dollars and sixty-six cents for postage, three hundred one dollars and forty-three cents (\$301.43) for supplies, sixty-two dollars and fifty-five cents (\$62.55) for travel and meals, Two Hundred eighty dollars and no cents (\$280.00) for health insurance, One thousand five hundred dollars and no cents (\$1500.00) for attorney fee to Ziontz & Chestnut Law Firm, six hundred ninety three dollars and fifty nine cents (\$693.59) to Steve Hanson Law Firm, two thousand five hundred eighty seven dollars and seven cents (\$2587.07) for Pow-wow Bingo, pursuant to the provisions of the Band Statute 1085-MLC-37, Section 66.

NOW THEREFORE BE IT RESOLVED, that Harry D. Simons, Commissioner of Finance is hereby authorized and directed to disburse fourteen thousand seven hundred twenty-four dollars and forty five cents (\$14,724.45) from the General Sales Taxation Account to the Administrative Operating Account.
