RESOLUTION 02-01-23-87

A CONTINUING RESOLUTION FOR THE PROGRAMMATIC, CORPORATE AND GOVERN-MENTAL ACCOUNT STRUCTURE FOR THE MILLE LACS BAND OF CHIPPEWA INDIANS FOR THE MONTHS OF JANUARY & FEBRUARY, 1987, WHICH IS IN LIEU OF A FORMAL APPROPRIATIONS STATUTE.

- WHEREAS, Ordinance 02-82, Section 8 mandates the appropriation of all Band revenue prior to the commencement of a new fiscal year; and,
- WHEREAS, the Band Assembly has not passed formal appropriations to continue the essential services to the enrolled members of the Mille lacs Band; and,
- WHEREAS, the Band Assembly of the Mille Lacs Band of Chippewa Indians continues to review all necessary financial information in order to ensure the financial integrity of the Band.
- NOW THEREFORE BE IT RESOLVED, that the Band Assembly for the Mille Lacs Band of Chippewa Indians hereby authorizes the continuance of the following programs for a period of fifty nine (59) days to expire on midnight February 28, 1987 said expenditures shall not exceed the amounts listed:
