RESOLUTION 02-03-43-88

A RESOLUTION AUTHORIZING A PROPOSAL REQUESTING A GRANT UNDER THE UNITED STATES DEPARTMENT OF EDUCATION BY THE ANISHINABE OPPORTUNITIES INDUSTRIALIZATION CENTER, INC. UNDER THE MILLE LACS BAND OF CHIPPEWA INDIANS.

- WHEREAS, the Mille Lacs Band Assembly (Reservation Business Committee) is the duly governing body of the Mille Lacs Reservation, fully authorized to act in behalf of its members; and,
- WHEREAS, the Anishinabe Opportunities Industrialization Center, Inc., a non-profit organization has been established within the boundaries of the Mille Lacs Reservation with approval of the Mille Lacs Band Assembly; and,
- WHEREAS, the United States Department of Education has available grant funds to assist tribal organizations in providing financial support to Indian tribes to plan, conduct and administer projects or portions of projects that are authorized by and consistent with the Carl D. Perkins Vocational Education Act (20 U.S.C. 2301 et seq); and,
- WHEREAS, the Mille Lacs Band of Chippewa Indians has a desire to have the Anishinabe Opportunities Industrialization Center, Inc. participate in the Carl D. Perkins Vocational Education Act; and,
- WHEREAS, the securing of additional grants would greatly assist the tribal government in establishing, maintaining and expanding programs and projects preventing unemployment and underemployment through additional vocational training.
- NOW THEREFORE BE IT RESOLVED, that the Mille Lacs Band of Chippewa Indians does hereby approve and authorize the submission of a proposal by the Anishinabe Opportunities Industrialization Center, Inc., to the United States Department of Education for a grant under the provisions of the Carl D. Perkins Vocational Education Act.
- IN WITNESS WHEREOF, we, the Anishinabe Opportunities Industrialization Center, Inc., Board membership hereunto cause to have set the signature of the Chief Executive to be affixed to this resolution and forwarded to the Band Assembly for concurrence.
