RESOLUTION 02-02--05-88

A RESOLUTION TO REQUEST THAT THE BUREAU OF INDIAN AFFAIRS TAKE NECESSARY ACTION TO PARTICIPATE WITH AITKIN AND PINE COUNTIES IN THE UPGRADING OF ACCESS ROADS AND HOUSING STREETS.

WHEREAS, the Mille Lacs Reservation has a continuing need for the construction of roads and streets; and,

WHEREAS, the Mille Lacs Reservation Public Works Commission is fully authorized under Band Statute 1010-MLC-6 with amendments, to act in behalf of the Mille Lacs Federation of Chippewa Indians in establishing the road construction priorities; and,

WHEREAS, to better meet the needs of the Reservation, the established priority list needs to be revised and updated from time to time; and,

WHEREAS, the establishment of new housing areas throughout the Reservation requires upgrading of access roads and housing streets.

NOW THEREFORE BE IT RESOLVED, that the Mille Lacs Reservation Public Works Commission hereby establishes the following priorities for road construction projects and requests that the Bureau of Indian Affairs take necessary action to complete these projects at the earliest possible date.

PRIORITY NO. 1 - Indian Route No. 8, Lake Lena Housing Road. Grade, drain, gravel base and bituminous surfacing - 0.7 miles.

PRIORITY NO. 2 - Indian Route No. 5, Isle Allotment Road. Grade, drain, gravel base and bituminous surfacing - 1.2 miles.

PRIORITY NO. 3 - Indian Route No. 9, East Lake Community Road. Grade, drain, gravel base and bituminous surfacing - 0.4 miles.

PRIORITY NO. 4 - Indian Route No. 60, East Lake North Housing Street. Grade, drain, gravel base and bituminous surfacing - 0.1 miles.

PRIORITY NO. 5 - Indian Route No. 6, Boyd Road. Grade, drain, gravel base and bituminous surfacing - 0.3 miles.

BE IT FURTHER RESOLVED, that the Bureau of Indian Affairs take necessary action to participate with Aitken and Pine County in the upgrading of the following roads:

PINE COUNTY ROAD NO. 173 - Lake Lena Housing Area Access

PINE COUNTY ROAD NO. 15 - Hinckley Housing Area Access

INDIAN ROUTE NO. 4001 - Spaulding Township Road, Aitken Co., East Lake - East Housing Road
