## RESOLUTION 02-04-58-88

A RESOLUTION IN SUPPORT OF THE BASIC CONCEPT OF ESTABLISHING A REPRESENTATIVE LIAISON BETWEEN THE VARIOUS BANDS/TRIBES AND THE MCKNIGHT FOUNDATION.

- WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body of the Mille Lacs Band of Chippewa Indians, fully authorized to act on behalf of its members, and;
- WHEREAS, the Mille Lacs Band of Chippewa Indians supports the basic concept of establishing a representative liaison between the various Bands/Tribes and the McKnight Foundation to the extent that this will assist McKnight in effectively fostering Economic Development on the various Reservations, and;
- WHEREAS, the Mille Lacs Band of Chippewa Indians reserves the right to approach the McKnight Foundation directly for funding where we feel the merits of the project make a direct approach appropriate, and;
- WHEREAS, the Mille Lacs Band of Chippewa Indians have the following additional concerns about the proposal:
  - 1) That the proposed structure will absorb an excessive amount of resources that could otherwise assist Economic Development on the Reservations.
  - 2) A newly created organization such as this could easily allow its own perpetuation to become the primary goal, with Economic Development becoming a secondary concern. Perhaps there is an existing organization that could assume this role of liaison between the Band/Tribes and McKnight?
  - 3) That the proposed Board be knowledgeable of and sensitive to the Economic Development situations faced by all Reservations, not just the larger more populous Reservations.
- NOW THEREFORE BE IT RESOLVED, that the Mille Lacs Band of Chippewa Indians hereby offers its full support of establishing a representative liaison between the various Bands/Tribes and McKnight.
- IN WITNESS WHEREOF, we, the Administrative Policy Board hereunto recommend the signature of the Chief Executive to be affixed to this resolution and forwarded to the Band Assembly for concurrence.
