
SPECIAL REVENUE  
RESOLUTION 03-02-18-89

A SPECIAL REVENUE RESOLUTION GRANTING DISBURSEMENT FROM THE  
GENERAL SALES TAXATION ACCOUNT TO THE ADMINISTRATIVE OPERATING  
ACCOUNT OF THE MILLE LACS BAND OF CHIPPEWA INDIANS.

WHEREAS, the Commissioner of Finance respectfully requests authorization to dis-  
burse five thousand one hundred eighty six dollars and seventy eight  
cents (\$ 5,186.78) from the General Sales Taxation Account to the Ad-  
ministrative Operating Account to cover the following: fifty dollars  
and no cents to Cass Lake Company, five hundred dollars and no cents  
for the moccasin game tournament, one hundred seven dollars and thirty  
nine cents for plaques from Greg Larsen Sports, twenty eight dollars  
and thirty five cents for supplies from Bang Printing, two hundred thir-  
ty five dollars and eighty three cents for telephone expenses, one hun-  
dred five dollars and twenty one cents to purchasing & supply, two thou-  
sand six hundred sixty dollars and no cents for the spiritual conference  
and one thousand five hundred dollars and no cents\*for mileage and per  
diem, pursuant to the provisions of Band Statute 1085-MLC-37, Section 66.


NOW THEREFORE BE IT RESOLVED, that Polly Williams, Commissioner of Finance is hereby  
authorized and directed to disburse five thousand one hundred eighty six  
dollars and seventy eight cents from the General Sales Taxation Account  
to the Administrative Operating Account to cover the above expenses.
