RESOLUTION 03-02-68-89

A RESOLUTION FROM THE MILLE LACS BAND OF CHIPPEWA INDIANS APPROVING THE PROPOSED BUDGET OF THE JUDICIAL BRANCH OF TRIBAL GOVERNMENT FOR THE COURT OF CENTRAL JURISDICTION FOR FISCAL YEAR 1989 - 1990.

- WHEREAS, the Mille Lacs Band Assembly (Reservation Business Committee) is the duly recognized governing body of the Mille Lacs Band of Chippewa Indians, and;
- WHEREAS, the Mille Lacs Band of Chippewa Indians is authorized to contract with federal, state and local governments for programs and services benefiting members of the reservation, and;
- WHEREAS, the Mille Lacs Band Assembly (Reservation Business Committee) has reviewed the proposed budget of the Judicial Branch of government for Fiscal Year 1989 - 1990, and;
- WHEREAS, the Mille Lacs Band Assembly (Reservation Business Committee) hereby supports the Court of Central Jurisdiction in their quest to promote equal protection and equal rights for Mille Lacs Band members and others who come under the jurisdiction of the Mille Lacs Band of Chippewa Indians.

NOW THEREFORE BE IT RESOLVED, that the Mille Lacs Band of Chippewa Indians Band Assembly hereby approves the proposed budget of the Judicial Branch of Government for the Court of Central Jurisdiction for fiscal year 1989 - 1990, in the following amounts:
