RESOLUTION 03-01-49-89

A RESOLUTION FROM THE MILLE LACS BAND OF CHIPPEWA INDIANS ENDORSING THE MINNEAPOLIS AREA COMMUNITY TRIBAL SCHOOLS (M.A.C.T.S, INC.) TO PROVIDE TRAINING AND TECHNICAL ASSISTANCE TO AREA SCHOOLS.

- WHEREAS, the Mille Lacs Band Assembly (Reservation Business Committee) is the duly elected governing body of the Mille Lacs Band of Chippewa Indians, and;
- WHEREAS, the Mille Lacs Band of Chippewa Indians is a sovereign, possessing jurisdiction and authority to exercise regulatory control within the boundaries of the Mille Lacs Reservation, and;
- WHEREAS, it is the obligation of the Mille Lacs Band of Chippewa Indians under the treaty of 1854 and P.L. 93-638 the Indian Self-Determination Act to assume responsibilities of self-determination, and;
- WHEREAS, the Mille Lacs Band of Chippewa Indians does consider the education of its people a top priority, and;
- WHEREAS, the Mille Lacs Band of Chippewa Indians recognizes the need for the Minneapolis Area Community Tribal Schools (M.A.C.T.S, Inc.) to provide training and technical assistance to area schools concerning education, including Chapter One and Special Education.

NOW THEREFORE BE IT RESOLVED, that the Mille Lacs Band Assembly hereby endorses the Minneapolis Area Community Tribal Schools (M.A.C.T.S, Inc.) to provide training and technical assistance to area schools. This resolution shall remain in effect until rescinded.

IN WITNESS WHEREOF, we, the Administrative Policy Board hereunto cause to have set the signature of the Chief Executive to be affixed to this resolution and forwarded to the Band Assembly for concurrence.
