RESOLUTION 04-01-09-90

A SPECIAL REVENUE RESOLUTION GRANTING DISBURSEMENT FROM THE GENERAL SALES TAXATION ACCOUNT TO THE ADMINISTRATIVE OPERATING ACCOUNT OF THE MILLE LACS BAND OF CHIPPEWA INDIANS.

WHEREAS, the Commissioner of Finance respectfully requests authorization to disburse seven thousand seventy one dollars and thirty three cents (\$ 7,071.33) from the General Sales Taxation Account to the Administrative Operating Account to cover the following: three thousand one hundred twenty nine dollars and twenty one cents to the Ziontz Law-firm, two hundred fifty dollars and no cents for reimbursement to Don Wedll, one hundred fifty dollars and no cents to Mille Lacs Lakers Women's Softball team, five hundred dollars and no cents for the Nay Ah Shing School Pow Wow, two hundred two dollars and twenty two cents to Purchasing & Supply, one hundred sixty six dollars and eighty cents to the St. Paul Pioneer Press, two hundred twenty five dollars and no cents to the Star Tribune, three hundred fourteen dollars and eighteen cents for telephone expenses, one hundred thirty three dollars and ninety two cents to the Duluth News Tribune, and two thousand dollars and no cents for mileage and per diem pursuant to the provisions of Band Statute 1085-MLC-37, Section 66.

NOW THEREFORE BE IT RESOLVED, that Polly Williams, Commissioner of Finance is hereby authorized and directed to disburse seven thousand seventy one dollars and thirty three cents from the General Sales Taxation Account to the Administrative Operating Account to cover the above expenses.
