Resolution 04-01-20-90

A RESOLUTION APPROVING THE HOUSING AUTHORITY APPLICATION FOR FUNDING TO CONSTRUCT NEW HOUSING ON THE MILLE LACS RESERVATION.

Whereas, The Mille Lacs Band of Chippewa Indians Band Assembly (a.k.a. the RBC) is the duly elected governing body of the Mille Lacs Reservation; and

Whereas, The number one priority of the Mille Lacs Band Assembly is to improve the overall quality of life for the people of the Mille Lacs Reservation; and

Whereas, The Mille lacs Indian Reservation suffers tremendously from a clearly documented shortage of decent affordable housing; and

Whereas, this clearly documented shortage of housing poses a direct and pervasive threat to the health, safety, welfare and economic security to the members of the Mille lacs Band of Chippewa Indians; and

Whereas, The Mille lacs Band of Chippewa Indians has not received any housing assistance from the United State Department of Housing and Urban Development; and

Whereas, the lack of housing assistance for the past five years from the U.S. Department of Housing and Urban Development has made a desperate housing situation on the Reservation into a full blown housing crisis; and

NOW, THEREFORE, BE IT RESOLVED, That the Mille Lacs Band of Chippewa Indians hereby approves this application from the Mille Lacs Reservation Housing Authority for new housing construction to the U.S. Department of Housing and Urban Development pursuant to the United States Housing Act of 1937

BE IT FURTHER RESOLVED, that the Mille Lacs Band of Chippewa Indians authorizes the submission of this application from the Mille Lacs Band of Chippewa Indians Housing Authority to the U.S. Department of Housing and Urban Development and supports their efforts to alleviate the housing shortage on the Mille Lacs

Reservation
