RESOLUTION 03-04-02-90

A RESOLUTION AUTHORIZING A GRANT APPLICATION BY THE MILLE LACS BAND OF CHIPPEWA INDIANS TO THE UNITED STATES DEPARTMENT OF HEALTH AND HUMAN SERVICES JOB OPPORTUNITIES AND BASIC SKILLS PROGRAM (JOBS).

- WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body of the Mille Lacs Band of Chippewa Indians and has the power and authority to make recommendations that will improve the economic status of the Mille Lacs Band of Chippewa Indians; and,
- WHEREAS, the Mille Lacs Band Assembly recognizes that traditionally high unemployment rates on the Mille Lacs Reservation have caused very serious social and economic problems, along with other forms of extreme hardship for the residents of the Mille Lacs Reservation Indian community; and,
- WHEREAS, the Mille Lacs Band of Chippewa Indians has designated the Anishinabe Opportunities Industrialization Center (AOIC) as the Band's official employment and training unit, so designated to fight the traditionally high levels of unemployment on the Reservation; and,
- WHEREAS, the United States Department of Health and Human Services is making resources available through the Job Opportunity and Basic Skills (JOBS) training program under the Family Support Act of 1988 (P.L. 100-485) to help lessen the negative effects high unemployment rates have on communities; and,
- WHEREAS, the Mille Lacs Band Assembly has determined that such resources, administered by the AOIC, can indeed help lessen the negative effects of high unemployment rates on the Mille Lacs Reservation Indian community.

NOW THEREFORE BE IT RESOLVED, that the Mille Lacs Band of Chippewa Indians does hereby approve and authorize the submission of a proposal to the United States Department of Health and Human Services for funding under the JOBS program of the Family Support Act of 1988 (P.L. 100-485).

BE IT FURTHER & FINALLY RESOLVED, that the Mille Lacs Band of Chippewa Indians designates the Anishinabe Opportunities Industrialization Center as the unit of the Band Government to administer and conduct the programming under the federal JOBS Program.

IN WITNESS WHEREOF, we, the Administrative Policy Board hereunto cause to have set the hand of the Chief Executive to be affixed to this resolution and forwarded to the Band Assembly for concurrence.
