### Legislative Branch of Tribal Government

#### RESOLUTION 04-01-60-90

A Resolution to transfer and withdraw the 20% set aside from Dockets 18C and Docket 18T Appropriations.

- WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body of the Mille Lacs Reservation, and
- WHEREAS the Mille Lacs Band Assembly is charged with day to day government operations of the Mille Lacs Reservation, which includes the Tribal Governmental Operations and the Economic Development Program of their Indian people, and
- WHEREAS, the Mille Lacs Reservation has the delegated authority to deal directly with the federal government for the plan and direction regarding the administration of judgment funds, and
- WHEREAS, the Mille Lacs Band Assembly desires to transfer and withdraw the 20% set-aside from Dockets 18C & 18T appropriations, plus accrued interest as of draw down date, from their Trust Fund Investments represented as follows.


