RESOLUTION 04-02-93-90

A RESOLUTION FROM THE MILLE LACS BAND OF CHIPPEWA INDIANS TO APPROVE A PROPOSAL TO THE INDIAN HEALTH SERVICE FOR ENVIRONMENTAL SAFETY FUNDS TO BE USED BY THE LAW ENFORCEMENT DEPARTMENT OF THE MILLE LACS BAND.

- WHEREAS, the Mille Lacs Band Assembly (Reservation Business Committee) is the duly elected recognized governing body of the Mille Lacs Band of Chippewa Indians fully authorized to act on behalf of its members; and,
- WHEREAS, the Mille Lacs Band Assembly's number one priority is to improve the overall quality of life for the people of the Mille Lacs Reservation; and,
- WHEREAS, the Band Statutes of the Mille Lacs Band authorized the establishment of the Law Enforcement Department of the Mille Lacs Band for the protection of the people of the Mille Lacs Band; and,
- WHEREAS, the administration of the Mille Lacs Band has made the eradication of alcoholism on the reservation one of the Band's long-term goals; and,
- WHEREAS, the Law Enforcement Department of the Mille Lacs Band of Chippewa Indians has committed itself to attempting to prevent deaths of Indian people which are directly related to the consumption of alcohol while operating motor vehicles.
- NOW, THEREFORE, BE IT RESOLVED, that the Band Assembly of the Mille Lacs Band hereforeto approves a proposal to be sent to the Indian Health Service, Bemidji, Minnesota, for the purpose of competing for grant monies to perform a Driving Under the Influence Initiative under the Law Enforcement Department of the Mille Lacs Band of Chippewa Indians.
- IN WITNESS WHEREOF, we, the Administrative Policy Board hereunto cause to have set the signature of the Chief Executive to be affixed to this resolution and forwarded to the Band Assembly for concurrence.
