RESOLUTION 04-01-62-90

A RESOLUTION FROM THE MILLE LACS BAND OF CHIPPEWA INDIANS SUPPORTING AN APPLICATION FOR FUNDING FROM THE ADMINISTRATION FOR NATIVE AMERICANS AND CERTIFYING COMPLIANCE WITH ALL APPLICABLE ASSURANCES.

- WHEREAS, the Mille Lacs Band Assembly is the duly elected representative body of the Mille Lacs Band of Chippewa Indians; and,
- WHEREAS, the Long Range Comprehensive Economic Development plan has long called for economic development that is based on the Band's culture and history; and,
- WHEREAS, the Construction and operation of a new Indian Museum on the Mille Lacs Reservation by the Minnesota Historical Society offers the Band a unique and perhaps singular opportunity to develop a model cultural center comprising the museum and a restaurant and hotel as related small business economic components; and,
- WHEREAS, this cultural commercial center will explore new culturally based income producing career opportunities for Native Americans, while serving as a living museum which will preserve and enhance our proud culture and history; and,
- WHEREAS, this cultural commercial center will assist the Band in defining and attracting a tourist market to enjoy the facility, learn much about Ojibwe culture and history, and support the commercial components of the cultural commercial center which will be constructed and operated through the attraction of significant non-federal resources to the project.
- NOW, THEREFORE BE IT RESOLVED, that the Mille Lacs Band Assembly enthusiastically supports the application to the Administration for Native Americans which will make this cultural commercial complex a reality.
- BE IT FURTHER & FINALLY RESOLVED, that the Mille Lacs Band Assembly certifies compliance with all the assurances required of the ANA and are contained in the application for funding.
- IN WITNESS WHEREOF, we, the Administrative Policy Board hereunto cause to have set the signature of the Chief Executive to be affixed to this resolution and forwarded to the Band Assembly for concurrence.
