RESOLUTION 04-02-100-90

A RESOLUTION GRANTING A LAND LEASE TO [REDACTED]

WHEREAS, [REDACTED] wishes the lease of a lot on the Mille Lacs Reservation for the purpose of a homesite; and,

WHEREAS, a tribal land lease is needed for the purpose of a homesite on tribal land for the Mille Lacs Reservation; and,

WHEREAS, said land is described as follows: That part of the Northeast Quarter of the Southwest Quarter, Section 18, Township 43 north, Range 27 West, of the Forth Principal Meridian, in Mille Lacs County, Minnesota, described as following: Commencing at the Southeast corner of said Northeast Quarter of the Southwest Quarter; thence North 00 degrees 53 minutes 33 seconds west 33.00 feet along the east line of said Northeast Quarter of the Southwest Quarter; thence North 89 degrees 58 minutes 27 seconds West 100.00 feet to the point of beginning; thence North 00 degrees 53 minutes 33 seconds West 200.00 feet; thence North 89 degrees 58 minutes 33 seconds East 200.00 feet; thence South 89 degrees 58 minutes 27 seconds East 100.00 feet to the point of beginning; and,


WHEREAS, the least will have to be for a period of 25 years plus 25 years effective September 4, 1990 for the purpose of a homesite.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves a lease be issued to [REDACTED] for a period of 25 years plus 25 years renewal effective September 4, 1990.


BE IT FURTHER & FINALLY RESOLVED, that leasee will utilize the provisions of this resolution within twelve (12) months, if provisions are not met, lease will then revert back to the Band.
