RESOLUTION 04-03-72-91

A RESOLUTION GRANTING OF A CLOSURE OF HIGHWAY 169 ACCESS ROAD AND ADDING A RIGHT HAND PASSING LANE.

- WHEREAS, the Mille Lacs Reservation Band Assembly (Reservation Business Committee) is the duly elected body of the Mille Lacs Band of Chippewa Indians, fully authorized to act on behalf of its members; and
- WHEREAS, Mille Lacs Band of Chippewa Indians, in conjunction with the Minnesota Department of Transportation, are planning to build a passing lane on the main highway and the service road on East trunk highway 169; and,
- WHEREAS, the Mille Lacs Band of Chippewa Indians is concerned about safety of the guests and employees of the Casino along with the safety of the Mille Lacs Band members; and,
- WHEREAS, the Mille Lacs Band Assembly has determined that closing the Highway 169 access road directly across the highway from the school, clinic, and Grand Casino, and adding a right hand passing lane on Highway 169 at the Grand Casino turn off will contribute greatly to the safety of Grand Casino guests, employees and Mille Lacs Band members.
- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band of Chippewa Indians authorizes the closure of the above referenced access to Highway 169, and the addition of the right hand passing lane at the Grand Casino turn off.
- BE IT FURTHER AND FINALLY RESOLVED, that the Mille Lacs Band of Chippewa Indians desires to enter into an agreement with the Minnesota Department of Transportation to perform the required routine maintenance on the designated roadways and requests that the Commissioner of Corporate Affairs negotiate and enter into such an agreement as soon as possible.
- WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of Legislators being present held on the 9th day of April, 1991, at Vineland, Minnesota by a vote of <u>3</u> FOR, <u>0</u> AGAINST, <u>0</u> SILENT.
