RESOLUTION 04-03-46-91

A RESOLUTION GRANTING A LAND LEASE TO GERALDINE DEFOE.

WHEREAS, Geraldine DeFoe wishes the lease of a lot on the Mille Lacs Reservation for the purpose of a homesite; and,

WHEREAS, a tribal land lease is needed for the purpose of a homesite on tribal land for the Mille Lacs Reservation; and,

WHEREAS, said land is described as follows: that part of the SW 1/4 S 1/4, Section 11 T41N, R17W, describes as follows: Commencing at the intersection of the South boundary line of said SW1/4 S W1/4 and the public road known as Markville Road, thence North over and along the center of said road a distance of 624 feet to the point of beginning of the tract to be herein described thence West and parallel to the South boundary line of said SW1/4 S W1/4 a distance of 208.8 feet; thence North and parallel to the East boundary line of said SW1/4 S W1/4 a distance of 208.8 feet to the center of the public road; thence South over and along the center line of the said public road a distance of 208.8 feet more or less to the point of beginning, subject to highway rights and intending hereby to convey a tract of one acre, more or less, Pine County, Minnesota; and,

WHEREAS, the lease will have to be for a period of 25 years plus 25 years effective February 13, 1991 for the purpose of a homesite.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves a lease be issued to Geraldine DeFoe for a period of 25 years plus 25 years renewal effective February 13, 1991.

BE IT FURTHER & FINALLY RESOLVED, that lessee will utilize the provisions of this resolution within twelve (12) months, if provisions are not met, lease will then revert back to the Band.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of Legislators being present held on the 13th day of February, 1991, at Vineland, Minnesota by a vote of ___ FOR, ___ AGAINST, ___ SILENT.

IN WITNESS WHEREOF, we, the Band Assembly hereunto cause to have set the hand of the Speaker of Assembly to be affixed to this resolution.
