A RESOLUTION GRANTING TRANSFER OF ENROLLMENT TO THE MILLE LACS BAND, MILLE LACS RESERVATION FROM THE WHITE EARTH RESERVATION OF THE MINNESOTA CHIPPEWA TRIBE


- WHEREAS, the Mille Lacs Band Assembly is the duly elected governing body of the Mille Lacs Reservation; and,
- WHEREAS, Mille Lacs Band Assembly screens all membership considerations; and,
- WHEREAS, the following people have requested relinquishment from enrollment with the White Earth Reservation and are requesting enrollment with the Mille Lacs Band, Mille Lacs Reservation; and,


