RESOLUTION 05-02-61 -92

A RESOLUTION IN SUPPORT OF A COOPERATIVE VENTURE WITH DON MCFARLAND AND RUDY HILLIG, (dba) PAUL BUNYAN NATURE LEARNING CENTER, BRAINERD, MINNESOTA.

- WHEREAS, the Mille Lacs Reservation Band Assembly is the duly elected governing body of the Non-Removable Mille Lacs Band of Ojibwe Indians; and,
- WHEREAS, the Mille Lacs Reservation Band Assembly has reviewed the project presentation by Don McFarland and Rudy Hillig; and,
- WHEREAS, the proposed venture consists of but not limited to a development of an accredited Nature Learning Center for students and teachers as well as for the general public; and,
- WHEREAS, the development of the Nature Learning Center is in the best interest of the environment and education of future generations to come; and.
- WHEREAS, the development of an accredited Nature Learning Center is in the best interest of the Mille Lacs Band of Ojibwe Indians as well as all people of the geographical location of said project; and,
- WHEREAS, the Mille Lacs Band Assembly hereby recognizes the need to preserve and protect the natural environment and that this must be accomplished through education, research of the natural sciences.
- NOW THEREFORE BE IT RESOLVED, that the Band Assembly hereby endorses, supports and encourages the development of the Paul Bunyan Nature Learning Center in Brainerd, Minnesota.
- BE IT FURTHER RESOLVED, that the Band Assembly hereby appoints District I Representative David Sam and Solid Waste Coordinator, Cater Kuehn as official representatives to the Board of Directors of the Paul Bunyan Nature Learning Center.
