
does not meet the 1/4 degree requirements for enrollment to the Minnesota Chippewa Tribe; and,

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly (Reservation Business Committee) denies the above application for enrollment because of failure to comply with requirements found in Article II of the Minnesota Chippewa Tribe Constitution.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of Legislators being present held on the 24th day of January, 1992, at Vineland, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
