RESOLUTION 05-01-02-92

A RESOLUTION TO AUTHORIZE THE MILLE LACS BAND OF CHIPPEWA INDIANS TO RECEIVE DOMESTIC ASSISTANCE GRANTS OR CONTRACTS FROM THE STATE OF MINNESOTA.

- WHEREAS, the Non-Removable Mille Lacs Band of Chippewa Indians is authorized to execute and administer contracts pursuant to the provisions of Article VI, Section (c) of the Constitution of the Minnesota Chippewa Tribe and Band Statute 1032-MLC-1; and,
- WHEREAS, funds are available through the state of Minnesota to provide programs and services to address the needs of the Non-Removable Mille Lacs Band of Chippewa Indians; and,
- WHEREAS, the Non-Removable Mille Lacs Band of Chippewa Indians desires to provide domestic assistance program to the members of the Band in the following areas: C.D. Treatment Programs; Mental Health Programs; Child Welfare Programs; Woman, Infants, and Children (WIC); Energy Assistance; Weatherization; and Block Grants.
- NOW THEREFORE BE IT RESOLVED, that the Non-Removable Mille Lacs Band of Chippewa Indians desires to enter into a contract with the State of Minnesota for domestic assistance programs for the benefit of the Mille Lacs Band members.
- BE IT FURTHER RESOLVED, that the Commissioner of Administration and the Commissioner of Human Services are authorized to sign on behalf of the Non-Removable Mille Lacs Band of Chippewa Indians.
- BE IT FURTHER AND FINALLY RESOLVED, that in the absence of the Commissioner of Administration, it is hereby authorized that the Assistant Commissioner of Administration be authorized to sign on behalf of the Commissioner of Administration.
- IN WITNESS WHEREOF, we, the Administrative Policy Board hereunto cause to have set the signature of the Chief Executive to be affixed to this resolution and forwarded to the Band Assembly for concurrence.
