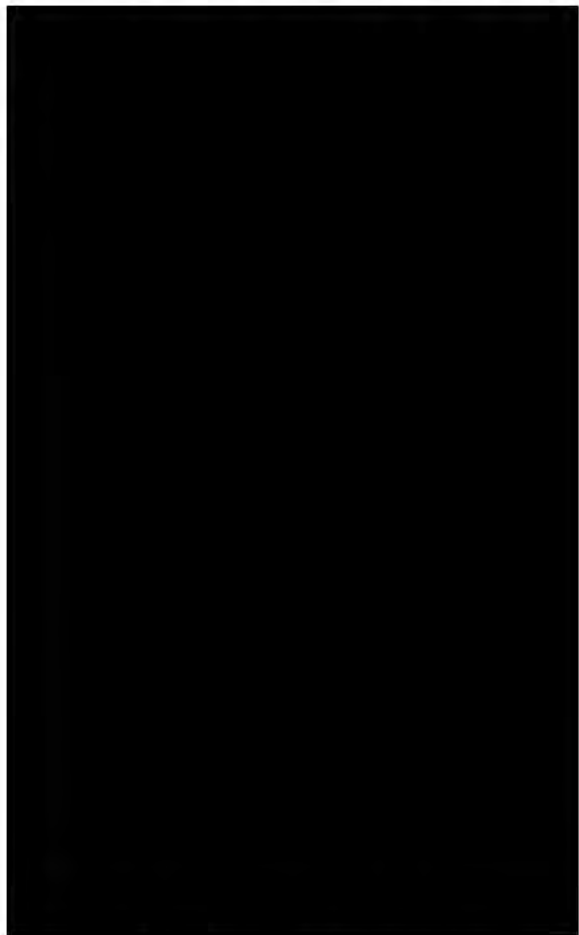
RESOLUTION 05-02-68-92


