RESOLUTION 04-04-17-92

A RESOLUTION PERTAINING	TO	NCAI	MEMBERSHIP.

- WHEREAS, the Mille Lacs Band wishes to become a Member Tribe in good standing of the National Congress of American Indians; and,
- WHEREAS, the Mille Lacs Band meets all requirements for Tribal Membership pursuant to Article II, Section 1,b of the Constitution of the National Congress of American Indians.
- NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly (Reservation Business Committee), which is the official governing body of the above named Tribe, hereby authorizes Marge Anderson, who is the principal Official of the Tribe, to take the necessary action to place the Tribe in membership in NCAI; and
- BE IT FURTHER RESOLVED, that tribal funds in the amount of \$145 based on the Tribal Membership dues schedule of the NCAI By-Laws (Article III, Section 1,b) authorized to be paid for such Tribal Membership in NCAI; and,
- BE IT FURTHER RESOLVED, that, based on membership of 2,400 persons, as verified by the records of the Minnesota Agency, the Tribe shall have 120 votes in accordance with Article IV, Section 3 of the NCAI Constitution; and,
- BE IT FURTHER AND FINALLY RESOLVED, that pursuant to Article V, Section 2 of the NCAI Constitution the Tribe designates the following named person(s) as Delegate and Alternate Delegate(s), and instructs them to become individual Member(s) in Good Standing in order to fulfill their responsibilities as Official Delegates to the National Congress of American Indians.
