RESOLUTION 05-01-30-92

A RESOLUTION GRANTING RIGHT OF WAY ACROSS LANDS UNDER THE JURISDICTION OF THE NON-REMOVABLE MILLE LACS BAND OF CHIPPEWA INDIANS TO THE BUREAU OF INDIAN AFFAIRS FOR THE PURPOSE OF IMPROVING ROADWAYS

WHEREAS, the Mille Lacs Band Assembly (Reservation Business Committee) is the duly elected governing body of the Mille Lacs Band of Chippewa Indians, and;

WHEREAS, the Mille Lacs Band Assembly is desirous of improving the rights and welfare of its members, and;

WHEREAS, the Bureau of Indian Affairs, Minneapolis Area Office, for the United States of America, its successors and assigns, have made application for a one hundred (100) foot right-of-way and an easement on additional land as required to construct and maintain cut and fill slopes, which may extend beyond the regular right-of-way across tribal lands in Sections 2 and 3, township 41 north, range 17 west, which lies 50 feet on either side of the following described centerline:

Lake Lena Housing Street:

Commencing at a point 71.33 feet northeasterly of the southeast corner of section 3, township 41 north, range 17 west, on an assumed bearing of N28-37-15E; thence N65-00-07W a tangent distance of 85.31 feet; thence on a 14 degree curve to the right a distance of 218.13 feet; thence N34-27-47W a tangent distance of 374.84 feet; thence on a 16 degree curve to the right a distance of 183.05 feet; thence N05-10-32W a tangent distance of 109.40 feet; thence on a 25 degree curve to the left a distance of f 167.04 feet; thence N46-56-12W a tangent distance of 243.23 feet; thence on a 6 degree curve to the right a distance of 79.72 feet; thence N42-09-12W a tangent distance of 152.52 feet; thence on a 16 degree curve to the right a distance of 145.61 feet; thence N18-51-22W a tangent distance of 281.85 feet; thence on a 7 degree curve to the left a distance of 139.68 feet; thence N28-38-02W a tangent distance of 635.21 feet; thence on a 20 degree curve to the right a distance of 164.36 feet; thence N12-57-27W a tangent distance of 52.50 feet; thence on a 20 degree curve to the left a distance of 141.38 feet; thence N41-13-52W a tangent distance of 245.14 feet to a point; said point being the end of project, also said point being approximately 605 feet east and 440 feet north of the center 1/4 corner, section 3, township 41 north, range 17 west, 4th principal meridian.

Lake Lena Community Center Street:

Commencing at point "A", which point is NO-03-53E, a distance of 120.58 feet and N37-41-33E a distance of 4026.41 feet and N49-19-13E a distance of 399.61 feet of the SW corner of section 2, township 41 north, range 17 west to point "A"; thence S32-18-07E a tangent distance of 342.64 feet to a point, said point being the end of project, also said point being approximately 320 feet east and 570 feet south of the north 1/16 corner, section 2, township 41 north, range 17 west, 4th principal meridian.

Located in Pine County in East Central Minnesota as shown in the map for the Lake Lena Housing Street and Lake Lena Community Street, for the purpose of constructing and maintaining an all weather road, and;

WHEREAS, all merchantable timber shall be salvaged and cut into merchantable lengths and piled along the road easement for disposal by the Branch of Forestry, and;

WHEREAS, all brush, stumps, and slash will be buried or burned in a safe and workmanlike manner, and;

WHEREAS, the purpose plate of the area has reviewed and it has been determined that the proposed improvement will provide an all weather roadway, safer control of traffic, more economical maintenance and benefit the members of the Mille Lacs Lake Indian Community.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of Legislators being present held on the 19thday of March , 1992, at McGregor, Minnesota by a vote of __3_FOR, __0_AGAINST, __0_SILENT.

IN WITNESS WHEREOF, we, the Band Assembly hereunto cause to have set the hand of the Speaker of Assembly to be affixed to this resolution.
