RESOLUTION 05-01-17-92

A RESOLUTION GRANTING RENEWAL OF LAND LEASE TO [REDACTED]

WHEREAS, the Mille Lacs Reservation Band Assembly (Reservation Business Committee) is the duly elected governing body of the Mille Lacs Band of Chippewa Indians; and,

WHEREAS, [REDACTED] wishes the continued lease of a lot on the Mille Lacs Reservation for the purpose of a homesite; and,

WHEREAS, a tribal land lease is needed for the purpose of homesites on tribal land for the Mille Lacs Reservation; and,

WHEREAS, the continued lease will be for a period of 25 years plus 25 years effective Februray 12th, 1992 for the purpose of a homesite.

WHEREAS, said land is described as follows: whence the NE corner of the SE 1/4 of NE 1/4, bears north 158 feet and 363 feet east of the NE corner of Lot 39, the point of beginning, thence south 60 feet to the SE corner of Lot 39, also NE corner Lot 4, thence west 200 feet to the SW corner of Lot 39, also NW corner Lot 4, thence north 60 feet to NW corner of Lot 39, thence east 200 feet to the NE corner Lot 39, the point of beginning in Section 28, Township 43N, Range 27W.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves a continuance of lease be issued to [REDACTED] for a period of 25 years plus 25 years renewal effective February 12th, 1992.

BE IT FURTHER RESOLVED, that leasee will continue to utilize the provisions of this resolution.

BE IT FURTHER AND FINALLY RESOLVED, that this lease shall be null and void should the leasee abandon or vacate the above described property for more than thirty days without prior approval of the Band Assembly.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative council assembled, a quorum of Legislators being present held on the 12th day of February, 1992 at Vineland, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.

IN WITNESS WHEREOF, we, the Band Assembly hereunto cause to have set the hand of the Speaker of Assembly to be affixed to this resolution.
