RESOLUTION 05-03-86-93

A RESOLUTION GRANTING A LAND LEASE TO [REDACTED]

WHEREAS, the Mille Lacs Reservation Band Assembly (Reservation Business Committee) is the duly elected governing body of the Mille Lacs Band of Chippewa Indians, and;

WHEREAS, [REDACTED] wishes the lease of a lot on the Mille Lacs Reservation for the purpose of a homesite, and;

WHEREAS, a tribal land lease is needed for the purpose of homesites on tribal lands for the Mille Lacs Reservation, and;

WHEREAS, the lease will be for a period of 25 years plus 25 years effective February 19, 1993 for the purpose of a homesite, and;

WHEREAS, said land is described as follows: That part of N 1/2 of the SE 1/4 NE 1/4 of the N 1/2 of SE 1/4 of Section 32, Township 49N, Range 23W, Shamrock Twp., Aitken County, State of Mn. Beginning at the intersection of the curve of Hwy. 73, thence South 625 feet (along road centerline), thence West 33 feet to point of beginning, thence West 410 feet, thence South 150 feet, thence East 410 feet, thence North 150 feet to point of beginning. Lake Minnewawa, Mud Lake Addition.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves a lease to be issued to [REDACTED] for a period of 25 years plus 25 years renewal effective February 19, 1993.

BE IT FURTHER RESOLVED, that lessee will utilize the provisions of this resolution within twelve (12) months, if provisions are not met, lease will then revert back to the Band.

BE IT FURTHER & FINALLY RESOLVED, that this lease shall be null and void should the lessee abandon or vacate the above described property for more than thirty (30) days without the prior approval by the Band Assembly.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 19 day of February, 1993 at Vineland, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
