RESOLUTION 05-03-94-93

A RESOLUTION GRANTING A LAND LEASE TO [REDACTED]

WHEREAS, the Mille Lacs Reservation Band Assembly (Reservation Business Committee) is the duly elected governing body of the Mille Lacs Band of Chippewa Indians, and;

WHEREAS, [REDACTED] wishes the lease of a lot on the Mille Lacs Reservation for the purpose of a homesite, and;

WHEREAS, a tribal land lease is needed for the purpose of homesites on tribal lands for the Mille Lacs Reservation, and;

WHEREAS, the lease will be for a period of 25 years plus 25 years effective March 3rd, 1993 for the purpose of a homesite, and;

WHEREAS, said land is described as follows: That part of S 1/2 NW 1/4 NW 1/4 of Section 28, Twp. 43N, R 27W, beginning at the Southeast corner of Allotment A-13, meander North 200 feet, thence West 200 feet, thence South 200 feet, thence West 200 feet to point of beginning, on Mille Lacs Reservation, Vineland Hills Addition, Kathio Township, State of Minnesota.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves a lease to be issued to [REDACTED] for a period of 25 years plus 25 years renewal effective March 3rd, 1993.

BE IT FURTHER RESOLVED, that leasee will utilize the provisions of this resolution within twelve (12) months, if provisions are not met, lease will then revert back to the Band.

BE IT FURTHER & FINALLY RESOLVED, that this lease shall be null and void should the leasee abandon or vacate the above described property for more than thirty (30) days without the prior approval by the Band Assembly.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 2 day of March, 1993 at Vineland, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
