RESOLUTION 05-03-106-93

A RESOLUTION AMENDING LAND LEASE TO [REDACTED] (RESOLUTION 04-02-100-90)

WHEREAS, the Mille Lacs Reservation Band Assembly (Reservation Business Committee) is the duly elected governing body of the Mille Lacs Band of Chippewa Indians, and;

WHEREAS, [REDACTED] wishes the lease of a lot on the Mille Lacs Reservation for the purpose of a homesite, and;

WHEREAS, tribal land leases are needed from the Band Assembly for the purpose of repayment of home loans-Minnesota Chippewa Tribe Home Loan Program in case of a default, and;

WHEREAS, said land is described as follows: That part of the Northeast Quarter of the SW Quarter, Section 18, Township 43 North, Range 27 West, of the Fourth Principal Meridian, in Mille Lacs County, Minnesota described as follows: commencing at the Southeast corner of said Northeast Quarter of the Southwest Quarter; thence North 00 degrees 53 minutes 33 seconds west 33.00 feet along the east line of said Northeast Quarter of the Southwest Quarter, thence North 89 degrees 58 minutes 27 seconds West 100.00 feet to the point of beginning; thence North 00 degrees 53 minutes 33 seconds West 200.00 feet; thence North 89 degrees 58 minutes 27 seconds West 100.00 feet; thence South 00 degrees 53 minutes 33 seconds East 200.00 feet; thence South 89 degrees 58 minutes 27 seconds East 100.00 feet to the point of beginning.

WHEREAS, the lease will have to be for a period of 25 years plus 25 years effective June 4th, 1993 for the purpose of financing this home.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly hereby approves a lease to be issued to [REDACTED] for a period of 25 years plus 25 years renewal effective June 4th, 1993.

BE IT FURTHER & FINALLY RESOLVED, that lessee will utilize the provisions of this resolution within twelve (12) months, if provisions are not met, or if the lessee defaults on their home mortgage this lease will then revert back to the Mille Lacs Band of Chippewa Indians.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 4th day of June, 1993 at Vineland, Minnesota by a vote of 2 FOR, 0 AGAINST, 0 SILENT.
