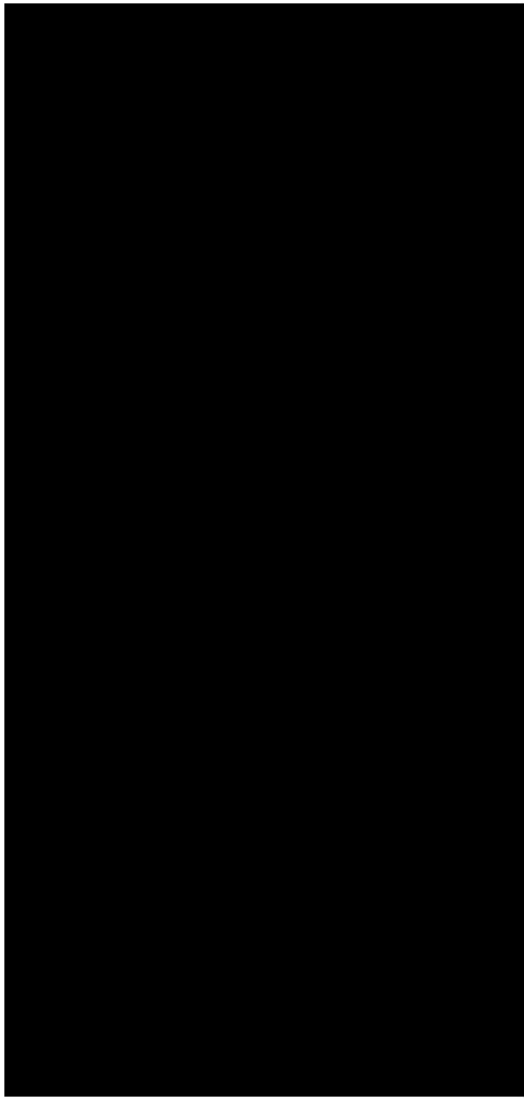

WHEREAS, the Mille Lacs Band Assembly (Reservation Business Committee) has reviewed Article II-Membership of the Revised Constitution and By-Laws of the Minnesota Chippewa Tribe.

NOW, THEREFORE, BE IT RESOLVED, that the Mille Lacs Band Assembly (Reservation Business Committee) denies the above applications for enrollment because of failure to comply with requirements found in Article II of the Minnesota Chippewa Tribal Constitution.

WE DO HEREBY CERTIFY, that the foregoing resolution was duly concurred with and adopted at a regular session of the Band Assembly in Legislative Council assembled, a quorum of legislators being present held on the 26th day of January, 1993 at Vineland, Minnesota by a vote of 3 FOR, 0 AGAINST, 0 SILENT.
